TERMS & CONDITIONS

1. THE RATES QUOTED MUST INCLUDE ALL APPLICABLE TAXES, TRANSPORTATION, AND SERVICE CHARGES.

3. THE SERVICE SHOULD MATCH THE STANDARDS OF PREVIOUS REFILLING JOBS.
4. REFILLING OF ALL FIRE EXTINGUISHERS INSTALLED AT VARIOUS LOCATIONS IN THE COLLEGE.
5. ENSURING THAT EXTINGUISHERS ARE IN PROPER WORKING CONDITION POST-REFILLING.
6. REFILL MUST BE DONE WITH ISI-MARKED MATERIALS AND COMPLY WITH RELEVANT SAFETY STANDARDS.
7. CONTRACTOR MUST ENSURE NO DAMAGE TO THE COLLEGE PROPERTY DURING THE WORK.
8. PAYMENT WILL BE MADE AFTER SATISFACTORY COMPLETION OF WORK AND SUBMISSION OF INSPECTION REPORT VERIFIED BY THE AUTHORITY.
